The Board of Managers of the Sand Hill River Watershed District met for their regular monthly meeting on March 6, 1979 in the basement of the Town and Country Cafe. Members present—Roland Gullekson, Daniel Wilkens, Vernon Larson, and Roger Hanson. Absent—Francis LaVoi.

Jim Ayen then presented his program on the Steve Ranz project. Motion was made by Dan Wilkens, seconded by Roger Hanson, and based on counsel's advise, the Chairman is authorized to sign the agreement to cosponsor the the Steve Ranz project with the West Polk Soil and Water Conservation District. Motion carried.

The Maple Creek petition was presented. Bob said he would take and review it, consult the attorney to find out if the required signatures were present, and prepare a comment for our next meeting.

It was suggested that at our next meeting we maybe lay out teams to take and check out our south boundary when the water is running right so we can get our boundaries all completed this year.

The Board of Managers of the Sand Hill River Watershed District met Thursday March 15, 1979 for the purpose of continuing the last recessed meeting with the landowners involved in the Bear Park project. Gullekson said the meeting didn't need to be called to order because it was a continuation of our last monthly meeting. Gullekson called on Bob to present the Bear Park project. Bob said all the water, up to a 50 year storm, would be taken care of by the structure and any over that would go over a low section of the road. At 1160 elevation we would have 1,979 acre-feet of water, and at 1162 elevation we would have 3,797 acre-feet of storage. Almost 4,000 acre-feet of water storage. 773 acres would be wet at the elevation of I160. 1,045 acres would be wet at the 1162 elevations
