On March 25th at 9:30 A.M., there will be a training session for the Region I Watershed directors. All the Board members were urged to attend.

Gale Fraser presented the resolution and operations plans of the Liberty-Onstad Ditch, Francis LaVoi made a motion to approve the operational plan for Project # 3. Motion seconded by Vernon Larson. Motion carried unanimously. Resolution and operational plan attached as Exhibit A & B.

The April 7th meeting of the Sand Hill River Watershed District will be at 8:00 P.M. As soon as we get the soils data on the proposed Hwy # 59 Project, we will arrange a meeting in Winger with the people involved.
