- 7. Sand Hill Ditch near Highway # 9.

 Pilings from an old Railroad bridge in the stream area of Sand Hill river were cut off leaving a long stump. The Railroad also has dumped rocks on the upstream side pf the railroad crossing to protect erosion. Some of these rocks have washed into the stream area. The rocks and the stumps cause a swirling action that may have been responsible for the large bank slide into the river just beyond the railroad right of way. Houston Engineering was authorized to set up the meeting.

 - 1986-7 Burke Bros. NW 240 acres Sec # 25 Russia Twp. Increase size of culverts on south side of County Highway # 41. Replace with 24" culverts. Also put in small culverts from field drains into county ditch on south edge of property.
- 9. Motion by Larson to raise fee to \$10.00 for each beaver disposed of on project # 1 by contract by the Board. Seconded by LaVoi. Motion passed unanimously.
