- 8. Steve Taylor, President of the Fertile Conservation club discussed the clubs plans regarding nesting sites for ducks and geese below the Bear Park Dam on 40 acres of land that they own. Board wanted completed plans before giving approval.
- 9. Philip Swenson reported that trees were beginning to grow in the Ditch area west of his building site-(Ditch 17-2). Also fallen trees in the ditch on Gullickson land was discussed. - WHEREAS, the Sand Hill River Watershed Board has failed to do this on a timely basis in the past and wishes to bring this oversite up to date.
- WHEREAS, Daniel Wilkens has served in this capacity as our representative since Lower Red River Watershed Management Board was established and Roland Gullekson has been our alternate of late.
- IT IS HEREBY RESOLVED, that Daniel Wilkens is our duly appointed representive to the Lower Red River Watershed Management Board and Roland Gullekson is the alternate for a term of three years. The Sand Hill River Watershed District term, according JOINT POWERS agreement by-laws terminated on December 31, 1976. The present 5 year term will expire on December 31, 1991.
