There was discussion that a Cam-Recorder would be used during the flight so a permanent record of the entire River would be available for future reference.

- 7. The Board decided to apply for a 1991 LCMR Grant to study sedimentation problems on water courses entering the Winger Dam Area. Wayne Goeken will write the Grant Application.
- 8. Gullekson gave a report on the meetings that he attended during the past month and other activities such as conversations with PCA, area farmers and other Board members.
- 9. There was discussion of recommendations for changes in the State Law for Watershed Districts.
- 10. Gullekson has received information that the State has sold Revenue Bonds for the Winger Dam. Gullekson will contact Roger Moe and Don Ogaard to to see if this is in fact true and find a means to remedy the situation.
- 11.Motion by LaVoi that Wilkens be authorized to work in the Lower Red River Watershed booth at the Red River Winter Shows on Wednesday February 21, 1990, 1:30 to 6:00 P.M. Motion seconded by Hanson. Motion passed unanimously.

- 12. Motion by Larson that Board members be authorized to attend the 1990 Aquaculture Conference March 2nd & 3rd at Breezy Point Resort. Motion seconded by Wilkens. Motion passed unanimously.
- 13. Motion by Hanson to recess at 12:00 to eat lunch. Motion seconded by Wilkens. Motion passed unanimously.
- 14. Meeting reconvened at 1:00 P.M Motion by Larson to pay current vouchers. Motion seconded by LaVoi. Motion passed unanimously.
