- 1. Attendance: Roger Hanson called the November 7, 1995 meeting to order at 8:00 a.m. at the District Office. Managers present were Jimmy Krogstad, Harold Vig, and Dan Wilkens. Glen Paulson, Ray Gullekson, and Lawrence Woodbury-SHRWD Engineer were also in attendance.
- 2. Agenda Review: No changes to the agenda were noted.
- 3. Minutes: Motion by Krogstad to approve the minutes of the October 3, 1995 SHRWD regular Board meeting as mailed. Motion seconded by Vig and carried unanimously.
- 4. Treasurer's Report: Wilkens reviewed the Treasurer's report and bills for payment. Motion by Krogstad and second by Vig to approve the Treasurer's report as presented and bills for payment. Motion carried <u>unanimously.</u>

5. Project Reports:

a.) Woodbury reported on the status of the railroad crossing over the Sand Hill River just south of Beltrami adjacent to Minnesota Hwy #9. Significant sloughing of the river bank in this area is occurring which had reached the point of endangering Gary Gullekson's driveway. Burlington Northern was proposing to come in and move Gullekson's driveway back further, reslope the slough area and install new culverts to address the problem. BN proceeded to reslope the area at a 2:1 slope which did not work as about 4 feet of the bank caved in within hours of the work being done. The failure area has expanded from 75 feet to 200 feet. Woodbury and Hanson visited the site and conveyed to BN that a 4:1 slope will be needed to control the situation. BN will also be bringing in 4 car loads of boulders to riprap the bank. BN had 80 feet of culvert that they were planning on installing and will now add an additional 30 feet to meet the needs at this location, b.) Beltrami Diversion: The status of the Beltrami Diversion Project was discussed along with options on how to proceed. Motion by Wilkens to authorize Houston Engineering to pursue development of a

- Step One application for assistance on this project to be presented to the Red River Water Management Board at their February meeting. Krogstad seconded the motion which carried unanimously.
- c.) Project #12: The appeal for dismissal of the project was heard by Judge Anderson on Monday, October 30, 1995 at the Polk County Courthouse in Crookston. Judge Anderson will be making a ruling within 30 days. In other matters relating to Project #12 Wilkens reported that the bond for the project has been increased to \$40,000 to cover past and projected expenses. Wilkens handed out signed agreements from Vineland Township regarding their participation in cost-sharing on portions of the project involving township road work and dirt removal.
- d.) Bear Park: Glen Paulson turned in 2 beaver tails that he trapped in the Bear Park project area and a billing for this work. Wilkens reviewed the beaver bounty program. After discussion Paulson decided to turn his beaver in to the township.
- 6. Report on Meetings and Activities During the Past Month:
 - -Included as part of Project Reports noted above.

7. Upcoming Meetings and Other Business:

- a.) Hanson reviewed mail that had been received since the last Board meeting including a review of upcoming meetings and conferences. Motion by Wilkens to authorize attendance at the following meetings: Hanson to a November 9th "Environmental Solutions" seminar in St. Paul; Krogstad and Wilkens to a November 15th EIS meeting in Thief River Falls; Hanson and Vig to The International Coalition's annual conference on November 15-17th in Fargo; and Hanson and Vig to the MAWD annual meeting on December 1-2 in Alexandria. Motion seconded by Vig and carried unanimously.
- b.) Secretarial and Treasury needs of the Sand Hill River Watershed District were discussed. An overview of duties that was prepared by Wilkens and Goeken was handed out for review. Motion by Krogstad to condense this list down and place an ad in area papers for a part time position to meet some of these needs. Second by Vig. Motion carried unanimously. The ad is to be placed in the Fertile, Fosston and Crookston newspapers as soon as possible so the Board can review applications at their regular December meeting.
