January 2, 2007 Meeting Minutes

- 1. Attendance: Chairman Roger Hanson called the January 2, 2007 meeting to order at 8:05 a.m. at the District Office. Other managers present were Bill Brekke, Gordon Sonstelie and Harold Vig. Others in attendance were Daniel Wilkens-Administrator, April Swenby-Administrative Assistant, Lawrence Woodbury-Houston Engineering, and Joyce Downs Landowner.
- Approval of the Agenda: A <u>Motion</u> was made by Manager Brekke to approve the agenda, <u>Seconded</u> by Manager Sonstelie, <u>Carried</u>.
- 3. Minutes: A <u>Motion</u> was made by Manager Brekke to approve the minutes of the SHRWD regular board meeting conducted on December 5, 2006, <u>Seconded</u> by Manager Vig, <u>Carried</u>.
- 4. **Treasurer's Report:** A <u>Motion</u> was made by Manager Vig to approve the treasurer's report for December, <u>Seconded</u> by Manager Sonstelie, <u>Carried.</u>

## 5. Engineer's Report:

**Project # 17:** Woodbury stated that seeding the upper end of the project is about all that remains to be done. Kern and Tabery informed Woodbury that Glen Nelson, a subcontractor hired by Kern and Tabery has requested additional money for his services. That issue will need to be worked out between the Contractor and sub contractor.

**Project # 21/Fish Passage-West Mill:** The project is complete except for a little work at the Texas crossing site and seeding at both sites. Woodbury will contact DNR Fisheries to discuss payment procedures.

**Project # 20/Polk County # 46:** Wilkens presented the WD attorney's timetable required for legal notice to landowners for the final hearing. The publication will need to be advertised for The Fertile Journal's issue dated January 10, 17, and 24, 2007. The Crookston Times issue dated January 8, 15, 22, 2007. The notice of hearing also needs to be posted in the Polk County Court House and sent to individual landowners. Wilkens will coordinate with Wade Opsahl and Erik Jones at Houston Engineering to meet the requirements of notice for the final hearing.

## **Dan's Monthly Report:**

**Project Team:** A Project Team meeting is schedule for Tuesday, January 9. The Project Team will discuss what needs to be modeled and the overall plan update.

**RRWMB:** The RRWMB will meet in St. Paul the morning of the January 16 in conjunction with the Legislative Briefing. Highlights from their previous meeting were given to the managers.

The District will work with Houston Engineering in publishing notices in *The Fertile Journal* and *The Crookston Times*, Wilkens will post a notice in the Polk County Courthouse. Individual notices will also be sent out.

**Ditch # 133:** Wilkens has gathered data from the Polk County Court House and the East Polk SWCD to use to develop an estimate of costs for Charles Balstad. Woodbury stated that this process is under the statures for establishing a new ditch. A bond will need to be acquired.

**BWSR Grant:** A <u>Motion</u> was made by Manager Sonstelie to authorize the Chairman to sign the contract with BWSR for the \$10,615.00 grant for the NRE portion of the Overall Plan Update, <u>Seconded</u> by Manager Vig, <u>Carried.</u>

**Chester Morvig Lake:** Wilkens drafted a letter to be sent to the landowners in this project. The managers made several suggestions and revisions were made. Wilkens will mail the letter to Sylvia Nelson with cc. to David and Linda Black, Regina Larson, and the Wild Rice Watershed District.
